was incorrect and that the Council does not meet the conditions required to exercise the General Power of Competence.

We recommend that before it provides positive responses to the assertion in the Annual Governance Statement, the Council carefully reviews the statement to ensure that its responses are accurate.

There are no further matters I wish to draw to the Council's attention.

### 1. Expenditure under S137 Local Government Act 1972

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £1350.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

#### 2. Disclosure note

Following feedback received during previous audit processes, Pendine Community Council acknowledges that it does not currently hold the statutory power to directly operate a motorhome park. The Council is actively working to address this issue in accordance with legal requirements and is exploring alternative, lawful arrangements for the ongoing management of the site. Options under consideration include leasing the facility to a third party or transferring it into a suitable trust structure. The Council is committed to resolving this matter as soon as practicably possible and will ensure that any future operational model complies fully with statutory obligations. Updates will be reflected in future budget planning and disclosures as appropriate.

# Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Pendine Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### **Audit opinion: Qualified**

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### **Basis of Qualification**

### **Annual Governance Statement**

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

Assertion 4: The Council operates the Hafan y Mor Motorhome Site. As a public body established by statute, the Council only has such powers to provide facilities as are conferred on it by law. The Mobile Homes (Wales) Act 2013, section 56 of which contains a power to provide sites for mobile homes. Section 62 of the same Act, however, defines a local authority as meaning the council of a Welsh county or county borough. In our view, community councils (like the Council) are not caught by this definition. Therefore, it my opinion, the Council may be acting ultra vires in its operation of the Motorhome site.

### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

## **General Power of Competence**

The Council has provided a positive response to assertion 10 in the Annual Governance Statement. I have confirmed with the Council that the response provided
